ADDENDUM TO TACO MEMBERSHIP AGREEMENT

(Multiple Owners of TACO Unit Accommodating Multiple Families at a Time)

This is an Addendum to a TACO Membership Agreement between me and The Glacier Club, Inc. (the "Club") of even date herewith. All capitalized terms not defined herein will have the meanings ascribed in the Membership Agreement or the Summary of TACO Membership Program, dated May 26, 2017 ("Summary").

We, the undersigned ("Unit Owners" or "we") represent that we jointly own the TACO Unit referenced in the Membership Agreement ("Unit"). We acknowledge that each Unit Owner is responsible for separate dues and capital reserve contribution, and each Unit Owner agrees to pay a full set of dues and capital reserve contribution corresponding to the membership category selected in the Membership Agreement, as well as fees and charges incurred by such Unit Owner. Each Unit Owner indicates below whether the Unit Owner elects single or family privileges and dues.

We join in the Membership Agreement and agree to the provisions of the Membership Agreement. We agree to be jointly and severally liable for all dues and capital reserve contributions associated with the membership for all Unit Owners. We understand that the privileges of all Unit Owners may be suspended or terminated in accordance with the Membership Documents if dues and capital reserve contribution associated with the membership and any fees and charges of any Unit Owner are not timely paid in accordance with the Membership Documents.

We agree that all written notices with respect to the TACO Membership from the Club shall be sent to the attention of the Unit Owner who signed the Membership Agreement ("Contact Unit Owner") to the address set forth in the Membership Agreement unless any Unit Owner gives written notice to the Club that such Unit Owner desires to be copied on any such written notice. The Unit Owners hereby authorize the Contact Unit Owner and give such Contact Unit Owner a power of attorney to act on behalf of all Unit Owners with respect to the TACO Membership and the Club may rely on any written notice or other communication received from such Contact Unit Owner, unless any Unit Owner gives written notice to the Club revoking such authorization.

Any Unit Owner may elect on a membership year basis to be inactive and not pay Club dues and capital reserve contribution or have privileges or change status from Family to Single or Single to Family

by giving written notice to the Club at least 30 days before the end of the membership year for the succeeding membership year, provided that at least one Unit Owner has privileges and pays Club dues and capital reserve contribution. If all Unit Owner give written notice of inactive status in a membership year, all Unit Owner shall jointly and severally be responsible for one set of Club dues and capital reserve contribution.

Any Unit Owner may arrange for his or her interest in the membership to be transferred to a transferee of his or her interest in the Unit upon such transferee signing a Club provided instrument agreeing to be bound by the Membership Agreement and the terms of this Addendum and payment of a transfer fee as determined by the Club from time to time.

All terms and provisions of this Addendum shall supersede and control over any conflicting terms in the Membership Agreement.

If a Unit Owner is married, the signatures of both the Unit Owner and spouse are required.
